This includes all claims arising as a result of using the facilities and equipment of Max Level Fitness & Athletics and with Tonya Robinson and/or Nathaniel Robinson (TNR Industries, LLC, DBA Max Level Fitness & Athletics), and engaging in any activities or any activities incidental thereto. On behalf of myself, my family, my heirs, or assigns, I hereby voluntarily waive all claims resulting from ordinary negligence.

Furthermore, I am aware that personal training, athletic enhancement and sports conditioning activities, as well as group health and fitness activities can range from vigorous cardiovascular activity (group aerobics, running, boxing, cycling, treadmills, etc.) to the strenuous exertion of strength training (e.g. free weights, weight machines, rope climbing, tire flipping, sled pulling or pushing, etc.). I understand that these and other physical activities with Tonya Robinson and/or Nathaniel Robinson (TNR Industries, LLC, DBA Max Level Fitness & Athletics) involve certain inherent risks, including but not limited to death, serious neck and spinal injuries resulting in complete or partial paralysis, heart attacks, and injury to bones, joints, or muscles. My participation is voluntary with full knowledge of such inherent risks of property damage, personal injury, or death.

I understand that running sneakers are not permitted for any activities at Max Level Fitness & Athletics and/ or with Tonya Robinson and/or Nathaniel Robinson (TNR Industries, LLC, DBA Max Level Fitness & Athletics), except for running, due to the nature of the multidirectional movement. I understand that I am able to wear athletic training sneakers, tennis shoes, basketball sneakers, indoor soccer sneakers, and any sneakers with a flat sole. If I attend a training session wearing running shoes, I understand that I will be advised not to train.

I understand that in signing this waiver, I confirm I have been cleared by my physician to participate in physical fitness activities. I understand that any pre-existing and/or new conditions, including but not limited to: heart condition, blood pressure issues, chest pain, dizziness, bone, joint or muscle problems, and drug prescriptions, must be discussed with my coach/trainer before continuing on in physical activities.

I understand that this waiver is intended to be as broad and inclusive as permitted by the laws of the state of New York and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further affirm that the venue for any legal proceedings shall be in the state of New York and Saratoga County.

I have read this form and fully understand that by signing this form, I am giving up legal rights and remedies that may be available to me for the ordinary negligence of Max Level Fitness & Athletics and Tonya Robinson and/or Nathaniel Robinson (TNR Industries, LLC, DBA Max Level Fitness & Athletics) or any of the parties listed above.
